# **National General Assembly for Local Government 2010 Resolutions**

# **Coalition Position**

#### MOTION:

Strategic Motion No: 31

Council: City of Fremantle for South West Group

Motion

That this National General Assembly seek the support of the Council of Australian Governments to have a nationally consistent approach to predicting sea level rise to 2100 to facilitate local and regional strategies for adaptation and mitigation of impacts on coastal communities and coastal development.

# **RESPONSE: Strategic Motion No 31:**

The Coalition supports adaptation measures to mitigate the impact of sea level rises on coastal communities and coastal development. In its Direct Action Plan, the Coalition committed \$126 million to establish a National Climate Change Adaptation Centre to help vulnerable sectors and regions understand the impacts of climate change and develop practical responses. This builds on the \$14.2 million National Climate Change Adaptation Program and complements a \$44 million CSIRO Adaptation Flagship.

#### **MOTION:**

That this National General Assembly calls on both the State and Federal Governments to provide financial assistance for the roll out of Energy Efficient Street lighting. Further, the Commonwealth Government commission a parliamentary or independent review of the approach of the Australian Energy Regulator in setting the policy, regulatory and pricing frameworks for sustainable street lighting in Australia.

Our Direct Action Plan offers incentives for the lowest cost emissions. A coordinated action to replace lights with more energy efficient globes could potentially qualify for support from the Emissions Reduction Fund.

The Coalition is in favour of sustainable energy-efficient measures. A Coalition Government would work with a range of industry groups including the Clean Energy Council, the Energy Efficiency

Council, the Green Buildings Council and the Property Council to develop complementary energy efficiency measures.

#### RESPONSE: Motion No: Reserved: 68

The Coalition has expressed deep concerns that the current federal Government has diverted funding from Landcare and other NRM projects in favour of federal and state government agencies and supports a refocusing of funding back to local groups and for Landcare.

In its election policy, the Coalition highlighted 3 key objectives in relation to Landcare:

- 1. Reduce the paperwork surrounding Landcare
- 2. Provide more direct funding to Landcare projects, to be spent at local and regional levels
- 3. Work towards 3 year funding, as required by groups

The Coalition's Landcare plans are connected to the Green Army which supports young people as paid volunteers to weed and transplant trees. Green Army coordinators would be paid an annual income of \$50,000. This is similar to this Motion's stated inclusion of specific funding for Landcare coordinators.
